- (i) A colour blind person shall not be eligible for recruitment. If at any stage of service career, a person is found to be colour blind, he will be medically boarded out as per SHAPE policy in vogue in the ITBPF.

(i) After completion of Written Examination and Interview, Merit list for each category namely, General, Scheduled Caste (SC), Scheduled Tribe (ST), OBC (NCL), EWS and Ex-servicemen will be drawn on the basis of combined marks obtained by the candidates in the Written Examination and Interview. On the basis of merit, the candidates shall be shortlisted for Verification of original documents and Detailed Medical

Examination (DME), as per the category-wise vacancies. The number of candidates examined will be equal to the number of vacancies increased by average failure rate of verification of original documents and DME/RME determined on the basis of past experience. However, there shall be no reserve list.

- (ii) SC, ST and OBC candidates who have come in the merit and have not availed any relaxed standard viz; age, height, chest and written examination, such candidates will be selected against Un-reserved vacancy.
- (iii) Selection of candidates will be made in order of merit in each category.
- (iv) For Ex-servicemen, separate merit list may be drawn under each category i.e. UR, SC, ST and OBC (NCL).
- (v) In case of recruitment to the vacancy reserved for Ex-servicemen and those remained unfilled due to non-availability of eligible or qualified Ex-servicemen candidates, the same shall be filled up from the Non Ex-servicemen candidates as per merit list of respective categories.

(vi) RESOLUTION OF TIE CASES:

Certificates obtained in any other format will not be accepted. Candidates claiming OBC status may note that certificate on Non-Creamy Layer status as per Annexure-'II-A' should be based on the income earned during three previous financial years (i.e. 2023-24, 2022-23 and 2021-22) and must ensure that he should be in possession of caste/community and Non-Creamy Layer (NCL) certificate before the closing date for submission of online applications, i.e. 8th January, 2025 (08/01/2025).
- (iv) Certificate as per **Annexure-'V'** for claiming relaxation in Height & Chest (if applicable).

Candidates who fail to submit N.O.C. at the time of documentation shall be summarily rejected.
