- (d) In Volleyball, the sports achievements in the events conducted by **Volleyball Federation of India** or its affiliated units after **25.06.2020** shall not be considered for recruitment.
  - However, Certificates issued under Aegis of Association of Indian Universities and the International Federations will be taken into consideration.

For claiming waiver of examination fee, Minorities candidates should submit 'self declaration' as mentioned in <a href="Annexure-III">Annexure-III</a>, At the time of Trial/Document Verification, such candidate claiming waiver of examination fee will be required to furnish 'minority community declaration' affidavit on non-judicial stamp paper that he/she belongs to any of the above minority communities. If 'self declaration' as mentioned in <a href="Annexure-III">Annexure-III</a> not uploaded with online application or the affidavit is not produced during Trial/Document Verification, their candidature will be rejected.
- \*\* Economically Backward Class (EBC) means those whose annual family income is less than Rs. 50,000/-. They have to submit income certificate at the time of applying in the prescribed format as given in <a href="Manexure-IV">Annexure-IV</a> on the letter head of the competent issuing authority.
- 6.1 While applying the candidates claiming fee exemption/refund must upload necessary certificates i.e. SC/ST/Minorities/EBC in prescribed format issued by competent authority.
- 6.2 After ensuring the correctness of the particulars in the application form, candidates are required to pay fees through the payment gateway on RRC-SCR website available on the RRC/SC webpage of South Central Railway website <a href="www.scr.indianrailways.gov.in">www.scr.indianrailways.gov.in</a> which has been integrated with the online application. Online fee payment through Net Banking or Debit/Credit Card will be available up to closing date i.e. 03.02.2025 till 23.59 Hrs. No change/edit will be allowed thereafter.
- 6.3 The payment can be made by using Debit Card/Credit Card/Net Banking/UPI etc. By providing information as per the instructions on the computer screen. Transaction charges levied by the Bank for online payment, if any, will be borne by the candidates.
- 6.4 On successful completion of the transaction e-receipt with the date entered by the candidate will be generated which should be saved/printed and retained by the candidate. The same should be produced on demand at the time of Trial/Document Verification.

#### 7. SELECTION PROCEDURE:-

- i. Selection will be based upon Document Verification, performance in Sports Trials and assessment of sports achievement & educational qualification etc. Selection will be conducted by South Central Railway, Headquarters, Secunderabad for vacancies of Head Quarter Quota and by respective Division for vacancies of Divisions Quota.
- **ii.** After scrutiny of applications by Scrutiny Committee short-listed eligible candidates will be called for Document Verification & Trial of sports performance. Candidates who will found

suitable in Document Verification by Document Verification Committee, Trials of those candidates will be conducted by Trial Committee. Trial Committee conduct trial to assess their sports performance and suitability for Railway/Unit team as well as Indian Railways team. Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage, by giving marks as per the criteria given below:-

For Game skill, physical fitness & coach's observations during trials	40 Marks	
FIT Candidate	Candidate securing 25 marks or more	
NOT FIT Candidate	Candidate securing marks below 25	

- **iii.** After Trial only the FIT Candidates in trial shall be considered for the next stage i.e. assessment of sports achievement & educational qualification by the Recruitment Committee.
- **iv.** Recruitment Committee shall award the marks (out of 60 marks) only to the FIT candidates for their sports achievements, educational qualifications etc. Candidates declared 'NOT FIT' will not be assessed further by the Recruitment Committee.
- **v.** Assessment of sports achievement & educational qualification of the FIT candidates shall invariably be held on the same day, just after trials or at the most, next day of the trials.
- **vi.** Recruitment Committee is to add the marks given by the Trial Committee to the FIT candidates (i.e., out of 40 marks), in order to make the final merit list (out of 100 marks.)
- vii. <u>Distribution of Marks</u>: Maximum marks which can be awarded by the Trial Committee for performance during Trial and Recruitment Committee during assessment of sports achievement & educational qualification, shall be as follows:

<u>Note</u>: The offer of appointment shall be given purely on the basis of merit. In case more than one sportsperson score the same marks, preference should be given to younger candidate to decide the merit.

#### 8. Important Instructions :-

- (i) Recruitments of sportspersons shall be dealt as per Railway Board's letter no. 2010/E (Sports)/4 (1)/1 (Policy) dated 31.12.2010 read with modifications/amendments issued by the Railway Board from time to time.
- (ii) Any subsequent changes in the terms and conditions of the Employment Notice as per extant rules will stand good. RRC reserves the right to consider/incorporate any subsequent changes/modification/additions/cancellation in the terms & conditions to recruitment under this Employment Notice as and when applicable.
- (iii) Applicant should possess requisite educational qualification and sports achievements before submitting the online application.

- (iv) In case any applicant has difficulty in filling their applications ON LINE, they are free to contact the help line numbers displayed on RRC website.
- (v) Signature of the applicant must be full and in running hand, **not in block/capital letter or disjointed letters.**
- (vi) Merely filling up online application on RRC website or issue of call letters for trial to the candidate will not imply that his candidature has been finally cleared. Candidate's admission at all stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions.
- (vii) Candidates belonging to SC/ST/Minorities/Economically Backward Class, claiming for less fee as mentioned in para 6.1 must upload self attested photocopy of requisite Caste Certificate/Minority Certificate or self-declaration/Income Certificate. Otherwise their candidature will be summarily rejected.
- (viii) All the recruitments against Open Advertisement quota shall be at the minimum of scale of pay in the Pay Matrix. Railway Administration reserves the rights to recruit eligible candidates. The decision of Railway Administration on all matters relating to eligibility, place, date, mode of selection, acceptance or rejection, recommendation of post, place of posting, grade etc. shall be final and binding on the candidates. No correspondence will be entertained in this regards. South Central Railway Administration reserves the right to decide the number of sports persons to be selected for any individual/team game depending upon their requirement for that sports and availability of suitable candidates fulfilling the norms.
- (ix) Candidate applying for more than one discipline/game or event shall submit separate application with separate examination fee along with all necessary documents for each discipline/game or event.
- (x) No request for change of Date & Venue will be entertained.
- (xi) No relaxation in Education/Sports Norms, Age shall be permissible.
- (xii) Sports persons having sports norms of higher pay matrix and applied against the vacancies for the lower pay matrix will be considered for applied level only if found eligible otherwise.
- (**xiii**) Candidate should be in readiness to appear for the Trials etc. at short notice after the last date for submission is over.
- (xiv) The list of Eligible/Ineligible candidates for trial will be uploaded on the website of Railway Recruitment Cell, Secunderabad. Call letters for Trial to the eligible candidates for appearing in the trial will be uploaded on the official website and the schedule of the trial will also be uploaded on the official website www.scr.indianrailways.gov.in.
- (xv) Sports person recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment are found incorrect/fake at any stage.
- (xvi) Candidates must bring all documents uploaded with online application form & other requisite documents in Original along with one set of self attested photo copies on the day of trial, without which they will not be allowed to appear in the Trial. Certificates in languages other than English or Hindi should be accompanied by a self attested translation in English/Hindi. Only copies of documents uploaded with the online application will be considered.
- (xvii) Candidature of those candidates, who fail to appear for trials and other selection procedures on the date and venue fixed for the purpose, will be cancelled without further notice.
- (xviii) Specific category/post in Level 2/3, Level 1 and place of posting will be decided by the Competent Authority after finalization of panel.

- (xix) Candidates recommended for appointment will have to pass the requisite medical examination in the prescribed medical standards for the post to be identified by the South Central Railway Administration.
- (xx) Selected candidates can be posted anywhere on South Central Railway.
- (xxi) Selected candidates will have to undergo training wherever training is prescribed for the post.
- (xxii) Selected candidates will have to submit "Service Bond" of 5 years at the time of appointment.
- (xxiii) All the candidates getting appointment through Sports Quota will undergo Probation Period of two years. If the performance of a person recruited on sports account is considered to be unsatisfactory, the probation period will be extended maximum up to two years and the person will have to improve his/her performance to get confirmed in appointment. Even after extended probation, if the performance is found unsatisfactory, then normal procedure will be followed for termination, before the completion of extended probation.
- (xxiv) Sportsperson recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination.
- (xxv) The decision of Railway Administration/Recruitment Committee in all matters relating to eligibility, acceptance or rejection of application, final selection, offer of appointment, suitability for South Central Railway/Indian Railway and assigning of Post & Pay Level/Grade Pay etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.
- (xxvi) Candidates who have been debarred for life from all RRB/RRC examinations or candidates who have been debarred for a specified period which is not yet completed need not apply in response to this employment notice.
