**8.** It is made clear that merely fulfilling the basic essential qualification does not automatically entitle a person to be called for written test. **9.** Applications will be shortlisted for further selection process on the basis of percentage of marks obtained in the essential qualification examination.

**11.** Date of Written Test / Skill Test/Physical Test will be intimated to eligible candidates separately. Examination will be conducted at Devlali, Nasik District (Maharashtra) only.

**13.** Candidates living with more than one spouse or married to another spouse while the first spouse is alive, shall not be eligible to apply.  
**14.** SC/ST/OBC/PwD candidate applying for UR post is not entitled to any relaxation in the age limit.  
**15.** Appointing Authority reserves the right to reject the candidature of a candidate for written test / skill test/Physical Test. The candidates to be called for the written test and skill test shall be shortlisted, by applying all or any of the slated norms. Benchmarking will be carried out, if found necessary to restrict the number of candidates to be called for written test. In such eventuality, screening of applications on .the basis of percentages of marks obtained in the examination for essential qualification may be carried out.  
**16.** Canvassing in any form and / or bringing any influence, political or otherwise shall be treated as a disqualification for the test / post. Interim queries shall not be entertained.  
**17.** Candidates who fulfil the eligibility criteria shall be subjected to selection process as per existing orders and the selected candidates shall be appointed only after verification of character and antecedent from Police authority and if found fit after medical examination.  
**18.** The candidates selected shall be governed by the provisions of the New Pension Scheme (NPS)-2004.  
**19.** Selected candidates shall be initially posted to any of the Defence Establishment at Nashik/ Devlali as per vacancy with subsequent All India Service transfer liability.  
**20.** No TA / DA is admissible to the candidates for appearing for written test/ skill test/Physical Test.
