

# American lawmakers unite to combat anti-Sikh hate

## Bill Against Discrimination Referred To US House Panel

**Bathinda:** A bill, 'Sikh American Anti-Discrimination', was introduced in the US Congress and referred to the US House committee on the judiciary. The bipartisan bill, moved by Congressmen Josh Gottheimer and David Valadao to direct the Attorney General to establish a task force on anti-Sikh hate and discrimination, was referred to the House Committee on the Judiciary on Jan 15, as per Congress.gov, the official US govt website.

Josh Gottheimer from the Democratic Party is a member of the House of Representatives (like an MP in India) from New Jersey's 5th congressional district, and David Valadao from the Republican Party is a member of the House of Representatives from California's 22nd congressional district. US-based Sikh groups are vehemently supporting the legislation to fight anti-Sikh discrimination.

The Sikh American Anti-Discrimination Act of 2025, a bipartisan piece of legislation, was introduced by Congressman Josh Gottheimer on Dec 19, 2025, to combat rising anti-Sikh hate by establishing

hing a task force by the department of justice (DOJ). Congressman Valadao also supported and introduced the bill.

The bill aims to address and combat rising anti-Sikh hate and discrimination in the US by creating a dedicated task force, developing a federal definition of anti-Sikhism, drafting a definition of anti-Sikh hate, developing an educational programme on anti-Sikh hate and discrimination to be disseminated to K-12 schools, law enforcement, and institutions of higher education, and drafting an annual report to Congress that provides an overview of hate crimes against Sikhs. It follows increased incidents of anti-Sikh bias, often stemming from mistaken identity, presuming Sikhs as Muslims on many occasions.

Sikhs are the 3rd most-targeted religious group in the country, and they witnessed

over 150 attacks in 2025. New Jersey is home to one of the nation's largest Sikh populations, with about 1 lakh Sikh residents.

The Sikh Coalition, Sikh American Legal Defense and Education Fund (SALDEF), New Jersey Sikh Gurdwara Council, the New Jersey Sikh Youth Alliance, and other groups supported the legislation.

As per Sikh groups, Congressman Josh Gottheimer, while introducing the bill 'Sikh American Anti-Discrimination Act of 2025', stated that Sikhism is a monotheistic, pragmatic, independent, and sovereign world religion. Sikhs are commonly identified by the wearing of turbans, long beards or moustaches, karas (iron bracelets) on their wrists, or kirpans. Kirpans are mandatory Sikh articles of faith carried by Amritdhari (initiated) Sikhs at all times. While some Sikhs

wear a combination of these items, others may be seen without a turban or facial hair.

Anti-Sikh hate and discrimination refer to any act, practice, policy, or conduct that denies, restricts, or infringes upon the rights of individuals based on their actual or perceived Sikh faith, identity, ancestry, or expression. This includes incidents or crimes targeting Sikhs, individuals perceived to be Sikh, Gurdwaras (Sikh houses of worship), Sikh organisations, and property. It encompasses various forms of violence, threats, and harassment that are primarily motivated by religious or racial hostility, bigotry, hatred, or prejudice against Sikhs.

Sikhs experienced bias-based violence since their arrival in this country more than a century ago. While some instances of anti-Sikh violence were linked to mistaken identity, there are several documented cases where Sikhs were specifically targeted due to their faith or other aspects of their identities.

"Sikhs remain disproportionately more likely to experience hate than the average American, and we are living through a period in which hateful rhetoric and violence against too many communities are on the rise. By creating a task force, this bill takes an important step towards accountability, prevention, and ensuring that our communities can live and worship safely and without fear," said Harman Singh, Executive Director, The Sikh Coalition.

**Chandigarh:** Launching a fresh round of scathing attacks on his counterpart in Punjab, Bhagwant Mann, and AAP supremo Arvind Kejriwal, Haryana chief minister **Nayab Singh Saini** on Saturday said AAP leaders had turned 'Rangla' (prosperous) Punjab into a 'Kangla' (bankrupt) state, and people there were desperately looking forward to BJP and PM Narendra Modi.

Saini, while interacting with mediapersons after releasing money for various welfare schemes — including the third instalment of Laado Luxmi Yojna, release of funds for crop damage, and stable management — also accused Kejriwal and the AAP of shielding Atishi for her remarks.

"In Punjab, Mann says that he shall give farmers a compensation of Rs 20,000 per acre, and Arvind Kejriwal claimed in Gujarat that Punjab farmers are given Rs

## THIRD INSTALMENT OF DEENDAYAL LADO LAKSHMI YOJANA RELEASED

**C**M Nayab Singh Saini digitally disbursed funds under various schemes directly into the beneficiaries' accounts. According to information, Saini released the third instalment of Deendayal Lado Lakshmi Yojana, and an amount of Rs 181 crore was deposited in the accounts of 8.6 lakh beneficiary women. With this, a total of Rs 441 crore was disbursed in three instalments, said Saini, adding that amendments were made to include more women under this scheme. He added that from Feb 2026, an amount of Rs 1,100 will be directly deposited in the beneficiary's savings account, and the balance amount of Rs 1,000 will be deposited in a govt-operated RD or FD account. Following this, Saini released an amount of Rs 659 crore under various welfare schemes for the farmers, claiming that farmer welfare is at the centre of our policies.

## Man accused of making extortion calls injured in encounter

**Bathinda:** The Bathinda police have arrested an accused, Sewak Singh, after a brief encounter from Katar Singh Wala village in the district on Saturday. Sewak Singh was wanted in a case involving a threat call to an immigration consultant. Bathinda SSP, Jyoti Yadav said that an immigration consultant, Beant Singh, from Gulabgarh village, has offices in Mohali and Dubai. He received calls from unknown numbers on Jan 9 and 10, in which the caller demanded Rs 1 crore, or he would face dire consequences. The police registered a case against an unknown person under relevant sections. During investigations, police traced his location in the area of Katar Singh Wala village. When a police party reached the area, Sewak Singh, riding a motorbike, fired at the police party. The police retaliated, and a bullet hit him in the leg. Sewak, who faces 2 cases under the NDPS Act and theft charges, was admitted to the civil hospital, Bathinda, said the SSP, adding that further investigations will be made to ascertain whether he is alone or working with some gang.

## 'Digital policing strengthens citizen safety'

**Chandigarh:** Additional chief secretary, home department, Dr Sumita Misra, said on Saturday that the adoption of digital policing platforms marked a significant step towards making policing more transparent, responsive and citizen-friendly.

She said technology-driven initiatives under the Digital Police framework empowered citizens while simultaneously enhancing the efficiency and effectiveness of law enforcement agencies.

Misra said the Digital Police portal (<https://digitalpolice.gov.in/>) developed under the ministry of home affairs, provided a comprehensive platform for citizens to access a wide range of police services online.

These included filing crime-related complaints, reporting cyber-crimes, tracking the status of complaints, obtaining copies of FIRs, and accessing information related to missing persons, stolen or recovered vehicles, and wanted criminals. The platform also enabled citizens to seek antecedent verification for domestic help, drivers, tenants and prospective employees, as well as to obtain police clearance certificates (PCCs), thereby reducing the need for repeated physical visits to police stations.
