Car driver booked for homicide after 3 killed in collision

A 28-YEAR-OLD car driver has been booked for culpable homicide and rash driving in connection with a fatal multi-vehicle collision that claimed the lives of three persons and left scores injured at the Sector 5-8 dividing road, Police said on Monday.

Police said Rahul, a resident of Kishangarh village, who was under influence of 'bhang' when the accident took place, was booked under sections 281 (rash or negligent driving/riding on a public way that endangers human life), 125(A) (endanger human life or personal safety due to rash or negligent behavior) and 105 (culpable homicide not amounting to murder) of the Bharatiya Nyaya Sanhita (BNS).

DSP (Central) Dalbir Singh said, "The chauffeur's blood sample has been sent for an examination to ascertain whether he was also under the influence of liquor."

CLEARs WASTE-TO-ENERGY PROJECT Centre places onus on MC for clearing legacy waste at Dadu Majra

MP Tewari slams MC and UT admin for glaring 'laxity', missed deadlines

THE LONG-PENDING Dadu Majra garbage dump issue has moved a step forward, with the Centre approving a Waste-to-Energy project and its financial share, while underscoring the local authorities' responsibility in clearing the site.

The Union Ministry of Urban Development and Housing, in a communication, approved a Waste-to-Energy project for Chandigarh and sanctioned the central share of funds. But the Union ministry also clarifies that the onus of clearing the legacy waste and ensuring bio-remediation of the Dadu Majra dumping ground rests with the Chandigarh Municipal Corporation and the UT Administration.

Chandigarh Lok Sabha member Manish Tewari said his repeated interventions in Parliament to have the Dadu Majra garbage mound eradicated and

With 100 percentile in Physics and Maths, Kapish, Aditya emerge Chandigarh toppers

AS THE National Testing Agency (NTA) released JEE Main 2026 results evening on Monday, Chandigarh got a reason to celebrate with two city candidates securing 100 percentile in Physics and Mathematics.

Mohali: Car window smashed at wedding venue, cash, gold ring stolen

UNIDENTIFIED THIEVES have reportedly smashed the window of a parked car, stole cash, a gold ring and important documents from a couple who had come to attend a wedding function. The incident occurred on Sunday afternoon in the parking area of Amaltas Farm. Police at the Zirakpur police station have registered a case and begun an investigation.

In his complaint, Arush Sharma (30), a resident of Santoshgarh in Una, said he had come with his wife to attend a friend's wedding on February 15. Around 1 pm, he parked his car (Hyundai Alcazar) in the farm's parking area. At about 4 pm, when they returned, they found the small rear window of the car broken and the door open.

On checking, three bags, a ladies' purse and his wallet were missing. The ladies' purse contained his wife's gold ring, while his wallet had important documents and about Rs 12,000 in cash. The complainant said, "I tried to search for the thieves myself, but found no clue, after which I reported the matter to the police." He added that the window appeared to have been broken with a sharp object.

After recording the statement, police registered a case under Section 305(2) of the BNS against unknown persons. CCTV footage from nearby cameras is being examined.
