Lawyer moves HC against Bar poll non-refundable fee

It Stands Ratified By SC: Maha Bar Council Chief

Pune/Chhatrapati Sambhajinagar: An advocate from Chhatrapati Sambhajinagar has filed a writ petition before the Aurangabad bench of the Bombay high court challenging the Bar Council of Maharashtra and Goa's (BCMG) election notification of Jan 22 prescribing a Rs1.25 lakh non-refundable deposit for an advocate to contest its poll slated for March 24.

Apart from seeking directions to quash and set aside the prescribed deposit as "illegal, arbitrary, exclusionary and violative of provisions under the Constitution of India", advocate Shirish Kamble has prayed for effective and enforceable vertical reservation for OBC, SC and ST ad-

vocates in the BCMG election. According to the high court's official website, the petition, registered on Feb 9, is slated for a hearing on Feb 13.

Kamble has also filed an objection with the BCMG office in Mumbai against the prescribed deposit with a plea to reduce the same.

The petitioner-advocate has contended, among other things, that the Amravati bench of the Andhra Pradesh High Court on Jan 5, 2026, quashed and set aside the Bar Council of India's (BCI) proceedings of Sept 25, 2025, that decided in favour of raising the non-refundable security deposit from Rs 1,00,000 to Rs 1.25 lakh for all state Bar Council elections. Yet the BCMG insistence on Rs 1.25 lakh deposit was legally unsustainable, he contended.

BCMG chairman Harshad Nimbalkar told TOI, "The BCMG election is being held as per the Supreme Court's directive seeking a phase-wise conduct of elections of all state Bar Councils. The non-refundable security deposit at Rs 1.25 lakh has been decided by the BCI for all the state bar

council elections and it stands ratified by the Supreme Court by way of a recent decision by the bench headed by the C.JI."

On Feb 5, the SC allowed a bunch of petitions by the BCI seeking transfer of multiple cases (pending on this issue) before different high courts to the Apex Court. The SC noted, "The aforesaid fee has been levied on a pan-India basis, keeping in view the total expenditure likely to be incurred by every State Bar Council. In some of the matters, the precarious financial condition of several state Bar Councils has been explained to us, especially as a result of the impact of the substantial reduction of registration/entry fee pursuant to the compliance of the judgment rendered by the court in Gaurav Kumar vs Union of India & Others passed in WP(C) 352/2023 on July 30, 2024."

ELECTION IN MARCH

"It goes without saying that contesting an election is an optional choice of a member of the Bar. Failure to levy a reasonable fee towards elec-

tion expenditure would result in the costs being passed on to members of the Bar, including those not interested in participating as candidates. The chilling effect of such an additional burden will ultimately be faced by young lawyers, who have just begun their career and who, for no reason attributable to them, will find themselves financially contributing towards the election corpus," the SC said.

The bench noted, "Contrary to it, we approve the BCI's decision to recover such expenditure from those contesting the election. If a candidate is serious enough to contest the election, there is no gain-saying that he must also bear the expenditure for such an election."

The SC said, "We are of the considered opinion that there is no necessity for any high court to interfere in the fee structure prescribed for conducting the election of state Bar Councils. These transfer petitions are allowed. All the relevant cases pending before different high courts are taken on board and the same are accordingly dismissed."

Man dies after run during cop hiring drive

Chhatrapati Sambhajinagar: A 26-year-old Parli resident taking part in the ongoing police recruitment drive in Beed died after complaining of uneasiness following the mandatory 1,600-metre run on Wednesday.

Police identified the deceased as Deepak Bhaskar Wavhale of Parli in Beed district.

CCTV footage revealed that Wavhale successfully completed the run at the Beed district police ground. "Around 12.55pm, he complained of exhaustion and uneasiness, and walked towards the medical room adjacent to the finishing point after resting briefly. A medical team and a doctor stationed at the ground attended to him. He was given preliminary treatment, including IV fluids. The team called for an ambulance after detecting a low pulse rate," an officer said.

Senior officers reached the medical camp at 1.08pm.

"He was declared dead by attending doctors soon after the officer said."

1.36L apply for Pune police recruitment

Pune: The city police has received over 1.36 lakh applications in response to their recruitment drive.

The recruitment process scheduled to begin on Feb 12 and will be conducted simultaneously at the Shivajinagar Police Headquarters ground and the State Reserve Police Force (SRPF) ground in Wanowrie.

Joint commissioner of police Ranjan Kumar Sharma told TOI, "We have 1,700 vacancies for police constables. For 105 driver vacancies, we received over 38,000 candidates applying," he said.

Shaktipeeth Latur villagers intensify strike

Chhatrapati Sambhajinagar: Tension prevailed in the Latur village of Renapur taluka in Latur district on Tuesday as a group of farmers staged protests against a land survey for the proposed Nagpur-Shaktipeeth Expressway. Some even climbed trees threatening to hang themselves, while others attempted to jump into the well to pose the protest.

Nagpur: BJP veteran and Balrampur MLA Sudhir Mungantiwar on Wednesday said the knife-edge victory in Chandrapur's mayoral polls was possible because CM Devendra Fadnavis agreed to sweeten the power-sharing formula with Sena (UBT) by offering a longer mayoral tenure. It was due to UBT's six corporators and last-minute abstentions by few corporators that helped BJP bag the seat by one vote — a feat which earned Mungantiwar the nickname of 'kingmaker'.

Speaking to reporters in Nagpur on Wednesday, Mungantiwar accepted there were two rival BJP factions in his home district, the other headed by Chandrapur MLA Kis-

Tawde elected BMC mayor amid ruckus by opposition

Mumbai: BJP's Ritu Tawde (53) was elected the 78th mayor of Mumbai, becoming the second corporator from the party to occupy the post after a gap of 44 years, and Shiv Sena's Sanjay Ghadi (56) was chosen deputy mayor on Wednesday at the first meeting of recently elected corporators in the BMC House.

Both were elected unopposed as the opposition Shiv Sena (UBT) and Congress had not put up a candidate. The naming of the new mayor and deputy mayor brought to an end the administrator's rule in the civic body after nearly four years, a period in which the BMC didn't have an elected House.

The BMC had been placed under an administrator after the previous House's five-year term ended in March 2022.

CM Devendra Fadnavis, who for the first time sat in the civic gallery on Wednesday and witnessed proceedings along with Dy CM Eknath Shinde, said, "An administrator's rule isn't acceptable in a democracy, and only an elected body should lead. That's

what has happened today." However, the nearly 100 opposition corporators made it difficult for the first civic body meeting to proceed smoothly, disrupting proceedings with slogans like "Thackeray aage badho, hum tumhare saath hai" and "50 khokhe ekdum ok". BJP corporators countered it by "Modi, Modi". Ex-mayor and UBT Sena's party leader in the BMC Kishori Pednekar objected to administrator Bhushan Gagrani presiding over the meeting, arguing that the seniormost corporator, Shradha Jadhav, should have been appointed instead. Gagrani said he had been authorised by the state
